## MINUTES

**6:00PM**

**Call Council Meeting to Order:** Mayor Good called the meeting to order at 6:01PM.

**Pledge of Allegiance:** Mayor Good led all in the Pledge of Allegiance.

**Establish Quorum:** Town Administrator Jones ascertained there was a quorum present, noting that Council Member Edge was absent.

**Presentations:** None

The agenda was amended to welcome Todd Handley, Public Works Administrator and Bob Palmer, Director of Engineering of Coweta County to discuss the paving at Wellsburg Station in Sharpsburg to discuss paving at Wellsburg Station. A discussion and clarification were held resulting in Council Member Teagle moving to approve the paving of all the streets utilizing all available LMIG funds to allocate required ARPA funds to pay for the repaving project. Council Member Pike seconded the motion – all in favor 4-0 with Councilmember Edge being absent. Mr. Handley also acknowledged receiving an email from Administrator Jones with potential IGA road projects and he would collaborate with Administrator Jones in addressing those projects.

- 1. Codification of Town Ordinances** - Codification of Ordinances a vote was taken to approve the CIVICPLUS (Municode) contract and to use \$23,695 of ARPA funds. Council Member Teagle moved to approve, and Council Member Polly Garlington seconded it. All in favor 4-0 with Councilmember Edge being absent.

**Public Comments:** Ms. Juli Coffey, a 6-year resident of Wellsburg Station subdivision, spoke briefly about the paving going on there and gave comments about her neighborhood.

**Polling of Council:** Council Member Teagle picked up brochures from Coweta County Library and gave them to Administrator Jones. It gives instructions for connecting to their system. Hoopla information is in it. Council Member Garlington commented that there should be work session meetings so that decisions could be made with more detail rather than quick decisions.


**Administrator's Report:** Administrator Jones updated that furniture quotes are coming in and will be brought to the next meeting. Computer update quotes from VC3 are being finalized and will be received by the end of the week. He informed Council that there is a graffiti problem around town property. Coweta County Sheriff's Department has been notified.

**Mayor's Updates:** None.


