TOWN OF SHARPSBURG MINUTES OF THE TOWN COUNCIL MEETING

June 20, 2005

A called meeting of the Sharpsburg Town Council was held Monday, June, 2005, at 7:30pm, in the Town of Sharpsburg at the Bridges Recreation Center.

Present were the following: Wendell Staley, Mayor; Derrick McElwaney, Mayor Pro-Tem; Stan Parten, Council Member; Clay Cole, Council Member; Robin Spradlin, Town Administrator; Donna Camp, Town Clerk, David Winkle, Town Attorney. Council Member Hyde was absent.

Mayor Staley called the meeting to order at 7:30pm.

The pledge of allegiance was recited.

The Town Clerk verified there was a quorum present.

Mayor Staley called for first reading of several Ordinances; Zoning and Zoning Map Ordinance, Stream Buffer Ordinance, Illicit Discharge and Illegal Connection Ordinance, Post Development Stormwater Management Ordinance and the Soil Erosion and Sedimentation Control Ordinance. Copies of all the Ordinances were previously presented to Council and were available for inspection by public. Motions to accept the Ordinances for first reading were as follows:

- ➤ Zoning and Zoning Map Ordinances Council Member Cole motioned, Council Member Parten seconded. Motion carried unanimously.
- Stream Buffer Ordinance Council Member Parten motioned, Council Member McElwaney seconded. Motion carried unanimously.
- ➤ Illicit Discharge and Illegal Connection Ordinance Council Member McElwaney motioned, Council Member Parten seconded. Motion carried unanimously.
- ➤ Post Development Stormwater Management Ordinance Council Member McElwaney motioned, Council Member Cole seconded. Motion carried unanimously.
- ➤ Soil Erosion and Sedimentation Control Ordinance Council Member Cole motioned, Council Member McElwaney seconded. Motion carried unanimously.

Council Member Parten motioned to sign the resolution to submit a letter to the Metropolitan North Georgia Water Planning District asking to amend the Long-Term Wastewater Management Plan. Council Member Cole seconded. Motion carried, unanimously. Council signed resolution.

Mayor Staley polled the Council for comments -

Council Member McElwaney said a citizen was having a hard time seeing around a bush coming out of the A&O Bridges Recreation Center. Also, the tree limbs are obstructing the view of oncoming traffic while turning off Terrentine Street onto Highway 154.

Mayor's Minutes - Reminded the citizens to vote tomorrow on the ELOST ballot.
