

**TOWN OF SHARPSBURG  
MINUTES OF THE TOWN COUNCIL MEETING**

**February 1, 2010**

A regular meeting of the Sharpsburg Town Council was held Monday, February 1, 2010, at 7:00m, in the Town of Sharpsburg at the Bridges Recreation Center.

Present were the following: Wendell Staley, Mayor; Gordy Anderson, Council Member; Celene Davenport, Council Member; Keith Rhodes, Council Member and Donna Camp, Town Clerk. Council Member Turner was absent.

Also in attendance were: Dr. Matt Davis, Jennifer Davis, Alan Starr, Mayor of Turin, Margaret Staley and Polly Garlington.

Mayor Staley called the meeting to order and the Pledge of Allegiance was delivered.

The Town Clerk verified there was a quorum present.

The minutes of the January 4, 2010 Council Meeting were reviewed and approved as written by unanimous vote, and were filed in the minute book of the Town.

Dr. Matthew Davis addressed the Mayor and Council about the 3<sup>rd</sup> Annual "Community Wellness Day" (formerly Kids Day America) on Saturday, April 24, 2010. Community Wellness Day is a national event that focuses on educating the members of our community on very important information which is critical to the total wellness of your citizens. Dr. Davis is asking that the Town of Sharpsburg continue to be an official participant by signing a resolution. The date for Community Wellness Day is April 24, 2010. Dr. Davis asked if several of the Council Members would participate in the events. The location will be at South Metro Ministries, 3935 Highway 34 E., Sharpsburg, GA.

Mayor Staley called for a motion to approve a resolution to proclaim April 24, 2010 "Community Wellness Day". Council Member Anderson motioned, Council Member Rhodes seconded. With a show of hands the motion carried, unanimously.

Public Comments - Polly Garlington commented that she is glad to see work being accomplished under the new administration.

Clerk's Comments - The office will be closed on February 15, 2010 due to President's Day.

Mayor's Minutes -

- Speed limit signs have been ordered for Terrentine Street.
- Gravel has been placed on Stovall Street in the curve where water has been standing.
- We have been evaluating the needs of the Library and discussing with the local Boy Scout Troop about the possibility of a scout working on the Library as an Eagle Scout Project.
- Looking at changing the façade on the recreation center building. Artist Kay Stanley is going to prepare a sketch of the building as it would look if it matched all the existing building in town.
- The signs that are in violation of the sign ordinance in town will be coming down.
- We repaired a broken water pipe in the storage room when we had the cold temperatures last month.
- We had the heat checked in the restrooms and they are now warmer.

There being no further business coming before the Council, the meeting was adjourned.
