

**TOWN OF SHARPSBURG
MINUTES OF THE TOWN COUNCIL MEETING**

April 5, 2010

A regular meeting of the Sharpsburg Town Council was held Monday, April 5, 2010, at 7:00pm, in the Town of Sharpsburg at the Bridges Recreation Center.

Present were the following: Wendell Staley, Mayor; Gordy Anderson, Council Member; Celene Davenport, Council Member; Keith Rhodes, Council Member; Connie Turner, Council Member and Donna Camp, Town Clerk.

Also in attendance were: Margaret Staley, Polly Garlington and Herb Bridges.

Mayor Staley called the meeting to order and the Pledge of Allegiance was delivered.

The Town Clerk verified there was a quorum present.

The minutes of the February 1, 2010 Council Meeting were reviewed and approved as written by unanimous vote, and were filed in the minute book of the Town.

Mayor Staley called for a motion to approve a resolution to enter into the Intergovernmental Agreement with Coweta County and the Board of Elections to conduct municipal elections for the Town. Council Member Davenport motioned, Council Member Anderson seconded. With a show of hands the motion carried, unanimously. Council Member Davenport motioned to allow the Mayor to have the authority to sign the contract on behalf of the Town, Council Member Rhodes, seconded. Motion carried with a show of hands, unanimously.

Council Member Davenport motioned to approve the LARP contract with GDOT for the resurfacing of Marsha Way and to allow the Mayor to sign the contracts on behalf of the Town, Council Member Rhodes seconded. Motion carried with a show of hands, unanimously.

Public Comments - Polly Garlington commented that she had heard several rumors about the purchase of land and different project for the town. Mayor Staley said that the Council would be addressing that later in the meeting.
