MINUTES OF THE TOWN COUNCIL MEETING

September 7, 2010

The regular meeting of the Sharpsburg Town Council was held Monday, September 7, 2010, at 7:00pm, in the Town of Sharpsburg at the Bridges Recreation Center.

Present were the following: Wendell Staley, Mayor; Gordy Anderson, Council Member; Connie Turner, Council Member; Celene Davenport, Council Member and Donna Camp, Town Clerk. Council Member Rhodes was absent.

Also in attendance was Bobby Vallencourt.

The Pledge of Allegiance was delivered.

The Town Clerk verified there was a quorum present.

Mayor Staley called the council meeting to order.

The minutes of the August 23, 2010 Council Meeting were reviewed and approved as written by unanimous vote, and were filed in the minute book of the Town.

Mayor Staley called for a motion to accept 1st reading of the zoning amendment for grocery store square footage & length of time to build after rezoning is approved. Council Member Davenport motioned to accept 1st reading. Council Member Anderson seconded. Motion carried with a show of hands, unanimously.

The recreation center renovations will begin tomorrow. Several changes have been made to reduce the cost. 1x4's will be replaced with 2x4's in the farrowing; HVAC will remain a 3-ton unit instead of upgrading to a 5-ton unit; returns will be located in the celling; Fiberglass doors will replace the wooden doors, they last longer and are less expensive. The closet left in the old kitchen will be used by the Quilting Ladies after the renovations are completed

The engineering work and concept plan on the Main Street Park is 90% complete and ready for review. The final plans will be drawn and submitted for approval by the Mayor and Council before construction begins.
