

**TOWN OF SHARPSBURG
MINUTES OF THE TOWN COUNCIL MEETING**

November 7, 2011

Public Hearing of the Sharpsburg Town Council was held Monday, November 7, 2011, at 7:00pm, in the Town of Sharpsburg at the Sharpsburg Recreation Center.

Present were the following: Wendell Staley, Mayor; Celene Davenport, Council Member; Keith Rhodes, Council Member; Connie Turner, Council Member; Donna Camp, Town Clerk. Council Member Anderson was absent.

Also in attendance were: Gwen Lyons and Polly Garlington.

Mayor Staley called the public hearing to order. The public hearing was to take public comments on the proposed Occupational Tax Ordinance that was presented for 1st Reading at the October 24th meeting. No comments were given. Council Member Davenport motioned to close the public hearing. Council Member Turner seconded. Motion carried unanimously.

Mayor Staley called the November meeting to order and the Pledge of Allegiance was delivered.

The Town Clerk verified there was a quorum present.

The minutes of the October 24, 2011 Council Meeting were postponed a review until there is a quorum of participating Council Members that were present at the October 24th meeting.
