#### TOWN OF SHARPSBURG MINUTES OF THE TOWN COUNCIL MEETING

#### March 5, 2012

A regular scheduled meeting of the Sharpsburg Town Council was held Monday, March 5, 2012, at 7:00pm, in the Town of Sharpsburg at the Sharpsburg Recreation Center.

Present were the following: Wendell Staley, Mayor; Celene Davenport, Council Member; Derrick McElwaney, Council Member; Donna Camp, Town Clerk. Council Members Anderson and Rhodes were absent.

Also in attendance were: David Hunt, Waste Industries; Jackie Hurron, Pollard Residential Waste Services; Aaron Kinder, C&C Sanitation and Polly Garlington.

Mayor Staley called the March meeting to order and the Pledge of Allegiance was delivered.

The Mayor verified there was a quorum present.

The minutes of the February 6, 2012 Council Meetings were reviewed and approved as written by unanimous vote, and were filed in the minute book of the Town.

Jay Jones, Coweta County Emergency Management Agency director, discussed the purpose of the Georgia Emergency Management Agency/Homeland Security Statewide Mutual Aid and Assistance Agreement. The purpose of the agreement is to provide for mutual assistance between the Participating Parties in managing any emergency or disaster that is duly declared by the governing authority of any political subdivision that is a Participating Party, whether arising from natural disaster, technological hazard, human caused disaster, civil emergency aspects of resource shortages, community disorders, insurgency, enemy attack, acts of terrorism, other significant events or a national security activity. The new agreement will be a 4 year renewal.

Mayor Staley called for a motion to enter into the Statewide Mutual Aid and Assistance Agreement with GEMA/Homeland Security. Council Member McElwaney motioned, Council Member Davenport seconded. Motion carried, unanimously.

Mayor and Council heard presentations from three solid waste providers. They included Waste Industries, Pollard Residential Waste Services and C&C Sanitation. Council Member Davenport motioned to table the decision on the waste services bid until the first meeting in April. Council Member McElwaney seconded. Motion carried, unanimously. See the attached bid sheets for the individual providers.

Mayor Staley discussed the upcoming need for a new multi-function printer. The current printer is malfunctioning and will need to be replaced soon. The service warranty is out and the company will cease to maintain the current printer. Council Member Davenport motioned to allow the purchase of a new printer when needed. Council Member McElwaney seconded. Motion carried, unanimously.
