# TOWN OF SHARPSBURG MINUTES OF THE TOWN COUNCIL MEETING

### May 7, 2012

A regular scheduled meeting of the Sharpsburg Town Council was held Monday, May 7, 2012, at 7:00pm, in the Town of Sharpsburg at the Sharpsburg Recreation Center.

Present were the following: Wendell Staley, Mayor; Celene Davenport, Council Member; Gordy Anderson, Council Member; Keith Rhodes, Council Member; Donna Camp, Town Clerk. Council Member McElwaney was absent.

Also in attendance were: Gary Sikes, Fayette County News and Polly Garlington.

Mayor Staley called the May meeting to order and the Pledge of Allegiance was delivered.

The Mayor verified there was a quorum present.

The minutes of the April 27, 2012 Council Meetings were reviewed and approved as written by unanimous vote, and were filed in the minute book of the Town.

Mayor Staley called for a motion to accept 1st Reading of the Amendment of Chapter 10 of Alcoholic Beverages, including authorization of licensing the package sales by retailers of both malt beverages and wine on Sundays between the hours of 12:30 p.m. to 11:30 p.m. This will not include alcohol by the drink sales. Council Member Davenport motioned to accept 1st Reading, Council Member Anderson seconded. Motion carried, unanimously.

Mayor Staley called for a motion to allow the Sharpsburg Stallions to hold their annual Spirit Day Activities on August 11, 2012 and to allow the streets to be barricades during the event. Council Member Davenport motioned, Council Member Anderson seconded. Motion carried, unanimously.

Mayor Staley presented a bid to construct a side entrance porch over the double doors coming into the recreation center. Council Member Anderson motion to accept the bid, Council Member Davenport seconded. After discussion Council Member Davenport withdrew his seconded motion and Council Member Anderson withdrew the 1st motion to accept the bid. Council Member Anderson motion to table the agenda item until a second bid is submitted for consideration. Council Member Davenport seconded. Motion carried, unanimously.
