

**TOWN OF SHARPSBURG
MINUTES OF THE TOWN COUNCIL MEETING**

December 9, 2013

A regular scheduled meeting of the Sharpsburg Town Council was held Monday, December 9, 2013, at 7:00pm, in the Town of Sharpsburg at the Sharpsburg Recreation Center.

Present were the following: Wendell Staley, Mayor; Clay Cole, Council Member; Celene Davenport, Council Member; Keith Rhodes, Council Member; Donna Camp, Town Clerk. Council Member McElwaney was absent.

Also in attendance were: Joe Bridges and Polly Garlington

Mayor Staley called the regular scheduled meeting to order and the Pledge of Allegiance was delivered.

The Clerk verified there was a quorum present.

The minutes of the November 4, 2013 Council Meeting were reviewed and approved as written by unanimous vote, and were filed in the minute book of the Town.

Mayor Staley asked for a motion on the lowering the alcohol license fee for retail consumption dealer (distilled spirits, malt beverage and wine) from \$5000.00 a year to a first year onetime fee of \$2000.00. Council Member Davenport motioned to accept first reading, Council Member Cole seconded. Council Member Cole asked that the wording be changed in the ordinance so it is more clear and understandable. Mayor Staley asked if Council Member Cole wanted to withdraw his motion and Council Member Davenport withdrew her motion. Council Member Davenport motioned to accept first reading with the wording to be changed in the ordinance so it is more clear and understandable, Council Member Cole seconded. Motion carried, unanimously.

Mayor Staley asked for a motion to allow the Mayor to execute the LOST agreement with Coweta County to include the Town of Moreland. Council Member Rhodes motioned to allow the Mayor to sign the documents, Council Member Cole seconded. Motion carried, unanimously.
